

**Notice on the Simplification of Visa Application Documents for Credit Card Holders
(BDO, BPI, RCBC, METROBANK) (Implementation period: '24.7.22~25.12.31)**

The Embassy of the Republic of Korea would like to announce the expansion notice on visa document simplification for credit card holders of BPI, RCBC and Metrobank from July 22, 2024 to December 31, 2025. The list of applicable credit cards are listed below.

Moreover, please be informed that the bank documents are the ONLY exempted or substituted documents in the said simplification process and all other general documents must still be submitted.

○ **Required Visa Application Document**

- Certificate of employment (original), copy of credit card(with card number), and latest 3 months credit card account monthly billing statements(copy)

- Submission of bank certificates, bank statements, and ITR are exempted for credit card holders and family members. Other documents, such as proof of relationship, are required.

* Exempted documents may still be submitted if preferred.
